An Air Force veteran, Wiley is a retired state district court judge who raises cattle in Leavenworth, Kansas. Wiley has held many leadership positions at The American Legion Post, Department, and National levels. He is a paid-up-for-life member of Byron H. Mehl American Legion Post 23 in Leavenworth and is a Past Department Commander of Kansas. He also represented the state as a member of The American Legion's National Executive Committee. Appointed by the Kansas governor as a district court judge in 2008, Wiley helped establish and preside over the Leavenworth County Veterans Treatment Court.

As Commander, Wiley is a strong advocate for The American Legion's "Be the One" mission to prevent veteran suicide. He emphasizes inclusivity in the Legion Family through the theme, Better Together!

Wiley and his wife, Sonia, have two children, Austin and Christy, and one grandson.

October 1932 (93 years ago)

- A <u>MEMBERSHIP</u> meeting will be held in Lincoln on Saturday, November 12th. At that time, it is believed 10,000 members can be reported. A banquet will be held in the evening other events of the day include an executive committee meeting in the morning followed by attendance at the Nebraska-Pittsburgh <u>FOOTBALL</u> game in the afternoon. A big block of seats will be reserved for Legionnaires. Ticket prices are \$2.50 plus tax.
- Any Legion member in Nebraska who has an argument with the Missus about going to a Legion meeting, or any wife of a Legion member who wants to make sure her husband goes to the meeting he says he is going to, can well envy Mr. and Mrs. Frank <u>MCNEELEY</u> of <u>NORFOLK</u>. The McNeeleys are one of several pairs in Nebraska where both husband and wife served during the war.
- One of the ceremonies at the recent national convention in Portland was the planting of a <u>TREE</u> in <u>SOIL</u> brought from the Nebraska City home of J. Sterling <u>MORTON</u>. Mrs. Lottie Rosencrans, Department <u>AUXILIARY</u> President, took with her to national convention some soil from around a tree at the Morton home which had been planted by President <u>CLEVELAND</u>.

October 1942 (83 years ago)

- <u>SCOTTSBLUFF</u> Post 5 recently voted that <u>DUES</u> of members in the armed services be paid by the post. It is estimated that about 12 members are now in the service.
- The American Legion <u>BILL</u> for the amendment of its 1919 charter to open membership to veterans of the second world war has cleared the first hurdle. On October 14, the House passed **SPRINGER** Bill (H.R. 7675) and sent it to the Senate.
- The SEVENTH District continues in the lead on 1943 membership standings, with more than three-fourths of its **QUOTA** already in.

Engaging the VA Through Technology: Secure Access, Communication, and Benefits

This month I am focusing on how in today's digital world, veterans have more opportunities than ever to securely connect with the benefits and services they've earned. As a Veteran Service Officer I use technology to communicate with both veterans and the United States Department of Veterans Affairs (VA). VA currently provides several mobile applications allowing veterans to manage health care, access benefits, and communicate directly with VA staff—all from their personal devices. Two critical gateways, **Login.gov** and **ID.me**, paired with VA's suite of mobile apps, make the process more convenient, secure, and efficient.

Login.gov (www.login.gov) is a government-provided sign-in service that lets veterans use a single account across multiple agencies. Instead of keeping track of different usernames and passwords, veterans can log in once and access:

- VA.gov (benefits and health resources)
- My Social Security (Social Security Administration)
- **USAJOBS** (federal employment opportunities)

ID.me (www.id.me/individuals) functions like a secure digital identity wallet. After completing a one-time verification process, veterans can use their credentials across government platforms, health care systems, and private businesses.

For Veterans, ID.me goes a step further by verifying military affiliation. This not only provides access to VA.gov and My HealtheVet but also unlocks exclusive military/veteran discounts from hundreds of retailers and service providers.

Why Veterans Should Consider Both

While Login.gov and ID.me provide similar services, not all agencies or companies accept both. VA allows veterans to use either platform, but many private companies rely solely on ID.me for military verification. By setting up both accounts, veterans maximize their access to government services and private benefits while also having a backup option if one system is temporarily unavailable.

VA Mobile Apps: Connecting on the Go

Once identity is verified through Login.gov, ID.me, or DS Logon, veterans can use VA mobile apps to manage their benefits and health care:

- VA Health and Benefits App A one-stop shop to view and download benefit letters, access digital VA ID cards, manage appointments, send secure messages, and check claims status.
- My HealtheVet and Secure Messaging Communicate directly with providers, request prescription refills, view test results, and download medical records.
- VA Video Connect Attend secure video appointments with VA health care providers from home, particularly valuable for rural veterans.
- Other Apps Annie (text-based health reminders), PTSD Coach, and MOVE! PTSD Coach provides additional support for wellness and mental health.

Through these apps access communication with the VA is streamlined, veterans can:

- Communicate securely with VA staff via messaging or video appointments.
- **Download official letters instantly**, including disability verification, homestead eligibility verification letters and service letters.
- Access support 24/7, whether through health reminders or mental health resources.

By creating Login.gov and ID.me accounts and downloading VA mobile apps, veterans gain secure, streamlined access to health care, benefits, and official documentation. These tools reduce paperwork, cut down on travel to VA facilities, and put control directly in veterans' hands. An accredited Veteran Service Officer can provide further one-on-one information regarding veteran benefits, go see one today.

Over the years, I have had email communication and phone calls with Ann Mills-Griffiths. Ann is Chairman Emeritus and Acting CEO of the National League of POW/MIA Families, chartered in May 1970. Ann has led the organization since August 1, 1978.

Their mission is simple, "seeking answers on the missing." At National Convention in Tampa, I was able to sit down with Ann and Ed Sykes for a long conversation about the POW/MIA issue, and what we are doing at the Nebraska American Legion.

Ann was at the convention to receive the American Legion Auxiliary Public Spirit Award, for contributions that positively impact communities through service to our veterans, and their families. Ann started her mission in honor of her brother, Commander James B. Mills, U.S. Navy, listed as MIA September 21, 1966, when his Navy F4B disappeared off radar. Due to a nearly miraculous site discovery, and dedication by DPAA's underwater archeologists, Mills remains were recovered and identified in August 2018. He was interred with full military honors at Arlington National Cemetery on August 24, 2019.

September 5, 2025, at a Blackhawk Association Meeting, I was visiting with another Blackhawk, Vic Musante, who works with Tours of Duty. Their primary focus is locating and recovering POW/MIA remains. Vic pointed out that our Blackhawks lost two Cobra Aircraft and four aviators in 1971. Vic has been working with Ed Sykes, and one of our aircraft that went down near where "Pappy" Kahler, one of our Nebraska MIAs went down. Such a small world.

This edition, I want to talk about Commander Charles H. Peters, of West Point, Nebraska. Peters was a member of Attack Squadron 155, Carrier Air Wing 15, aboard the USS Constellation. On July 1, 1966, he piloted an A-4E Skyhawk 150017 on a strike mission over North Vietnam. While returning from the mission, the Skyhawk was shot down by enemy ground fire, and Commander Peters was killed. Hostile presence in the area inhibited search efforts at the time. In 1988, the Vietnamese government repatriated remains.

On October 14, 1989, the Central Identification Lab – Hawaii, (now DPAA), identified the remains of Commander Charles Henry Peters, missing from the Vietnam War.

Commander Peters is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific. His name is also inscribed along with all of his fallen comrades on the Vietnam Memorial Wall in Washington, D.C.

Tours of Duty and Task Force Omega have questioned why, after all these years, so much information on our missing heroes is classified. We have questioned what "they" are hiding. Many of us have asked that the so-called McCain Act of 1993 be reversed so that information can be declassified. In my conversation with Ann Mills-Griffiths, she said, "no, don't do that;" and went on to suggest that declassifying information would only fuel the conspiracy theorists, and not help our quest to find the missing remains of our heroes.

We are encouraged, all of us, to promote awareness of our still missing and unidentified Soldiers, Sailors, Airmen and Marines from all wars and conflicts; and continue to support the mission of No Service Member Left Behind.

For the 36th consecutive year, the Nebraska American Legion has done its part in helping Nebraska students with scholarship money.

Membership Minute Membership Chairman Steve Bartos

I'm glad to see that we're off to a much better start than we were last year. Because of the department and national dues increases, some members chose not to renew for 2025. Because we didn't get our first dues notice from Indianapolis until October, we fell behind the rest of the country on renewals.

The dues increase was probably the most impactful event on our disappointing results. However, just about every department in the American Legion struggled to achieve its goal. The national organization admitted at the National Membership Workshop that the declines were not totally unexpected --- and adjusted 2026 goals accordingly.

The first national membership target date was September 10th (50% of goal). Nebraska achieved that and surpassed that goal by having 10,465 paid members on that date. 51.33%. Thanks to everyone who transmitted dues to help us meet that goal.

Early and prompt renewals by our "regular" members are always a big help in kick-starting our membership year. The drawing for our "Early Bird" winners was held at Commander Walters' homecoming in Ainsworth. Congratulations to the following five members who will each receive a \$200 prize: Mary Beth Sueppel Hewitt of Bellevue --- Papillion Post 32; Arthur Bickley of Piedmont, Oklahoma --- Madison Post 35; Kenneth Bright of Wilber --- Wilber Post 101; Neal Anderson of Ansley --- Ansley Post 153; and Michael Cain of North Platte --- Hershey Post 279

The second national target date occurs on October 15th, and we should be at or over 55% of goal by then. I'd like to see us at 65% --- a full "target date ahead!" The second renewal notice from Indianapolis is scheduled to be mailed October 4-10, so there should be a fresh influx of memberships just before the target date. Be prepared to process them!!!

While it's important to keep processing memberships, we can't lose sight of the fact that our membership continues to decline. We must find a way to add "new" members to our rosters.

Losing members to non-renewal and losing members to the Post Everlasting are issues that won't go away. The losses to the Post Everlasting are probably of greatest concern. Our membership is generally top-heavy with older veterans, and the losses are more likely to come from that age group.

A feature that was lost when the "new" version of MyLegion was created was the ability to search for and sort the members of our Headquarters Post 500 by "join date." That was a very handy feature, because you could then create a list on a regular schedule, sort by "join date," and quickly see who the best prospects were to invite to transfer to your post ----- those being the names at the top of the list. They are members who have just RECENTLY joined the American Legion and are probably most likely to transfer. This feature has now been restored, and I encourage every post to use it. Members renew at a higher rate in the local posts, so let's get more of the Post 500 members transferred into one.

Renew. Reinstate. Recruit. Have a nice October.

Is following legislation even worthwhile? There is no doubt that it is difficult for one voice to be heard in Congress, or even in the Nebraska Legislature. However, a myriad of voices, all advocating for the same legislation, will most definitely make a difference.

The GI Bill, arguably one of the greatest pieces of legislation to come out of the Twentieth Century, was passed through bipartisan efforts led by the American Legion Family. Some more recent examples of TAL Family successes are:

• Honoring Our Promise to Address Comprehensive Toxics

(PACT) Act to improve health care access and funding for veterans exposed to toxic substances during their military service; and

• Protecting Moms Who Served Act to improve maternity care programs at VA facilities.

What legislation is the American Legion Family supporting now? There are several pieces of legislation being promoted by TAL. One of those that will undoubtedly touch the hearts of ALA members is the Love Lives on Act (S. 410/H.R. 1004), legislation to assist America's Gold Star spouses. Currently, Gold Star spouses under the age of 55 are expected to either forego remarriage and keep the benefits provided by their veteran spouses' service or choose a second chance for happiness and thereby lose those same benefits.

The Love Lives On Act would: • Eliminate the age limit for

remarrying without loss of benefits Allow remarried surviving spouses to retain education benefits.

• Preserve Commissary and Exchange benefits for remarried spouses; and

• Enable remarried spouses to regain TRICARE benefits if the subsequent marriage ends.

You can also request email alerts to help you keep track of legislation important to the Legion Family.


Always remember that one voice may not make a difference on its own, but a symphony can produce change. So let's work together over the coming year to serve America's veterans well.

• Flag Day is June 14 every year. However, you could pick any day to educate children about the flag and patriotism. Emblem Sales has a "Let's Be Right on Flag Etiquette" that you could donate to the schools.


RED CROSS HONORS KATHY ISKE'S 90TH BIRTHDAY WITH BLOOD DRIVE


