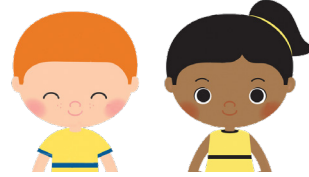
### **2023 ANNUAL POST DATA REPORT**

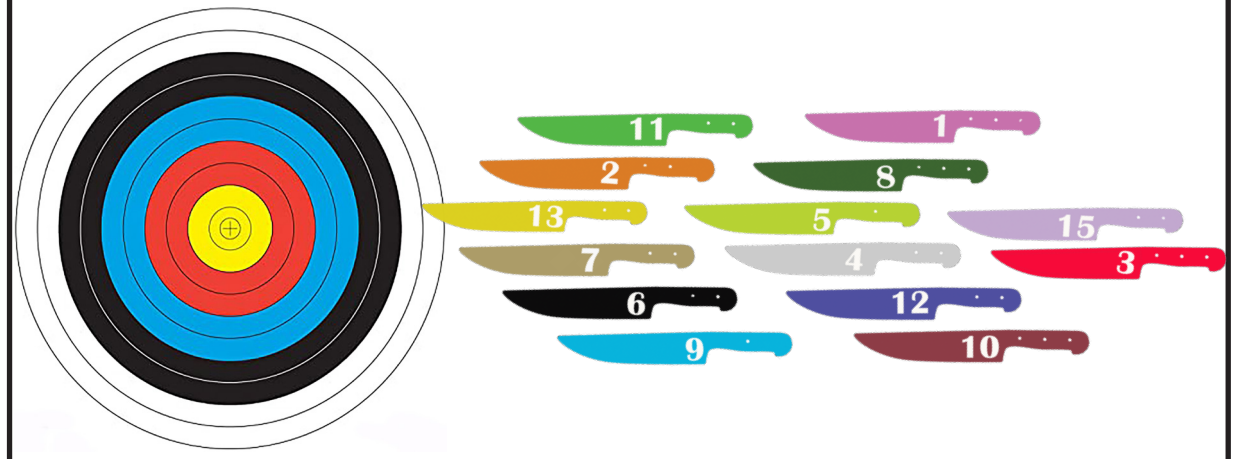

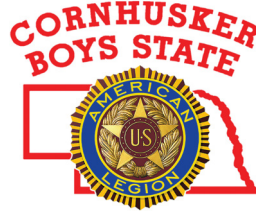

The deadline for filing Form 990-N for all Nebraska American Legion Posts is May 15. Form 990-N must be filed every year, or the post could lose its tax-exempt status.

### **DELAYED MEMBERSHIP TRANSMITTALS**

Memberships not transmitted in a timely manner can prove costly. If a Legionnaire is not current in their membership and tragedy strikes – it is possible they would not be entitled to the benefits and programs of The American Legion since you must be a member in good standing to apply for National Emergency Funds and collect on the Legionnaire Insurance Trust (just to name a couple). Don't put the Post, Legionnaire, or the family into that predicament. Make it a point to turn in memberships every two weeks.

### **HIGH SCHOOL VOLUNTEERS**

Did you know many High Schools require students to complete so many volunteer hours before graduation? Has your Post ever considered reaching out to a local High School and partnering with them to start a volunteer program? These students could help the Post in administrative duties like online activities, mailings, and other tasks. This mutual relationship is a win for both the Post and the volunteer. WHEREAS, The American Legion, Department of Nebraska, Bylaws state in Article XII, "Section 1. The American Legion, Department of Nebraska, is empowered to accept and receive gifts, devises or bequests of funds, chattels, money or real estate, or the income there from.

Section 2. The property shall be administered by trustees hereinafter designated as hereinafter provided. All funds received by the said trustees shall be held in trust for The American Legion, Department of Nebraska, and all moneys, securities, or other chattel property shall be deposited by the Department Finance Officer of The American Legion, Department of Nebraska, in a suitable and responsible depository; and the bond of said Department Finance Officer shall cover said trust fund deposits.

Section 3. The trustees shall use due diligence to invest promptly and keep invested any and all moneys belonging to the principal of said trust in interest bearing bonds or obligations of the United States of America, or of a state or any political subdivision thereof; or in first mortgages on improved Nebraska real estate, in an amount not over 40% of the appraised value thereof.

Section 4. The trustees shall make an annual report to the Department Convention of The American Legion each year of the receipts and expenditures of all sums and items of property; and shall, at the request of the Department Executive Committee of The American Legion, Department of Nebraska, make such special reports to said committee as it shall request.

Section 5. In instances where the donor or donors of any gifts, devises or bequests shall expressly direct the purpose for which the same shall be used, or the manner of the use thereof, such directions shall be followed by the trustees. In all other instances the Department Executive Committee of The American Legion, Department of Nebraska, shall by resolution provide for the use of such moneys.

Section 6. The trustees shall be the Department Finance Committee as now existing and their successors in office.

Section 7. The title of all property of the trust hereby created shall be vested in said trustees or their successors, and in case of property, real or personal, the trustees shall have the power to sell, lease, transfer or exchange all or any part of said property; and to execute as trustees, good and sufficient deeds of conveyance thereof, unless alienation of said property is restricted by the original gift or devise.

Section 8. The trustees shall serve without compensation and only the necessary expense of administering said trust shall be deducted therefrom.”; now, therefore, be it

**RESOLVED, By The American Legion, Department of Nebraska, in regular convention assembled in Columbus, Nebraska, on June 23, 24, 25, 26, 2022, That the Bylaws Article XII be changed effective June 26, 2022, to read:**

**“Section 1. The American Legion, Department of Nebraska, is empowered to accept and receive gifts, devises or bequests of funds, chattels, money or real estate, or the income there from.**

**Section 2. The property shall be administered by trustees ~~the Department Finance Committee (DFC)~~ hereinafter designated as hereinafter provided ~~and their successors in office~~. All funds received by the said trustees ~~DFC~~ shall be held in trust for The American Legion, Department of Nebraska, and all moneys, securities, or other chattel property shall be deposited by the Department Finance Officer of The American Legion, Department of Nebraska, in a suitable and responsible depository; and the bond of said Department Finance Officer shall cover said trust fund deposits.**

**Section 3. The trustees ~~DFC~~ shall use due diligence to invest promptly and keep invested any and all moneys belonging to the principal of said trust in interest bearing bonds or obligations of the United States of America, or of a state or any political subdivision thereof; or in first mortgages on improved Nebraska real estate, in an amount not over 40% of the appraised value thereof ~~all bequests including renewing, extending, surrendering or reinvesting as the DFC shall direct.~~**

**Section 4. The trustees ~~DFC~~ shall make an annual report to the Department Convention of The American Legion each year of the receipts and expenditures of all sums and items of property; and shall, at the request of the Department Executive Committee of The American Legion, Department of Nebraska, make such special reports to said committee as it shall request.**

**Section 5. In instances where the donor or donors of any gifts, devises or bequests shall expressly direct the purpose for which the same shall be used, or the manner of the use thereof, such directions shall be followed by the trustees**



**DFC.** In all other instances the Department Executive Committee of The American Legion, Department of Nebraska, shall by resolution **majority vote**, provide for the use of such moneys.

~~Section 6. The trustees shall be the Department Finance Committee as now existing and their successors in office.~~

WHEREAS, The National Executive Committeeman and the Alternate National Executive Committeeman are an important link between the National Executive Committee and the Department Executive Committee; and

WHEREAS, There had always been an agreement that the National Executive Committeeman and the Alternate National Executive Committeeman were seated at Department Executive Committee meetings with voice and no vote; and

WHEREAS, For some reason that agreement was broken; and

WHEREAS, At the Department Executive Committee on January 8, 2020 in Kearney, NE a motion was made seconded and passed to seat the National Executive Committeeman and Alternate National Executive Committeeman at Department Executive Committee Meetings with voice and no vote; now, therefore, be it

**RESOLVED, By The American Legion, Department of Nebraska, in regular convention assembled in Columbus, Nebraska, on June 23, 24, 25, 26, 2022, That the National Executive Committeeman and Alternate National Executive Committeeman shall have voice but no vote on the Department Executive Committee; and, be it further**

**RESOLVED, That Article VII Section 1 of the Department Constitution read “The executive and administrative authority of the Department shall be vested in the Department Executive Committee as herein otherwise provided. The Department Executive Committee shall be composed of the Department Commander, the three immediate Past Department Commanders, the Department Senior Vice Commander, the Area Vice Commanders, the District Commanders, the National Executive Committeeman, and the Alternate National Executive Committeeman. All the aforementioned shall have voice and vote except the National Executive Committeeman and Alternate National Executive Committeeman who shall have voice only.”; and, be it finally**

**RESOLVED, That the last sentence of Article III Section 1 of the Department Bylaws be changed to read “With the exception of the Legislative Committee, the Constitution and Bylaws Committee, and the Distinguished Guest Committee, no member of the Department Executive Committee shall serve on a standing committee.”**

WHEREAS, Article II, Section 1, of the Department Bylaws; state when the meetings are to held but doesn't elaborate on the "how"; and

WHEREAS, COVID Virus demonstrated that there are rare occasions when the DEC is unable to meet face-to-face and that alternative means of conducting business must be addressed for future occurrences that may prevent face-to-face meetings; and

WHEREAS, Many avenues exist to conduct formal meetings electronically using an array of webhosting platforms; now, therefore, be it

**RESOLVED, By The American Legion, Department of Nebraska, in regular convention assembled in Columbus, Nebraska, on June 23, 24, 25, 26, 2022, That Article II, Section 1, of the Department Bylaws be expanded from, "The Department Executive Committee shall meet immediately upon adjournment of the Department Convention; a second meeting shall be held prior to March 1, and a third meeting immediately prior to the annual Department Convention." to read, "The Department Executive Committee shall meet immediately upon adjournment of the Department Convention; a second meeting shall be held prior to March 1, and a third meeting immediately prior to the annual Department Convention. In most cases, meetings will be conducted in-person but on those rare occasions when uncontrollable, catastrophic circumstances prevent in-person meetings, the Department Commander is authorized to conduct the DEC meeting, or any other committee meeting, electronically and all business of the Nebraska American Legion can be administered provided the necessary quorum is present."**

WHEREAS, One of the basic purposes of The American Legion is “our devotion to mutual helpfulness”; and

WHEREAS, Part of the Veterans Affairs & Rehabilitation Commission’s purpose is to ensure that veterans and their families receive the highest quality of care for their injuries and illnesses incurred from their military service; and

WHEREAS, The American Legion motto is “Veterans Strengthening America”; and  
WHEREAS, As members of The American Legion, we have a sacred obligation to leave no veteran behind; ensuring that our veterans are cared for; and

WHEREAS, Current veteran suicides average 22 per day and the 2021 Department of Veterans Affairs (VA) National Suicide Prevention Report indicated that in 2019, the adjusted rate for veterans was 52.3% greater than non-Veteran U.S. adults; and

WHEREAS, The 2021 VA National Suicide Prevention Report stated that 45,861 U.S. adults committed suicide and 6,261 of these were veterans; and

WHEREAS, The White House released a national strategy on November 3, 2021, for preventing veteran suicide, purporting that it would harness the full breadth of the federal government to tackle the issue; this strategy aims to limit barriers to mental health care; and

WHEREAS, The VA has a gatekeeper training program provided by VA suicide prevention coordinators to veterans and those who serve veterans; and

WHEREAS, Other organizations have developed very successful and valuable suicide awareness and prevention training programs; and

WHEREAS, The American Legion is developing an action oriented campaign to change the narrative of veteran suicide; and

WHEREAS, The American Legion encourages suicide prevention training; Resolution No. 58(NEC, May 7-8, 2003), Subject: "Youth Suicide Prevention Education" resolves to increase youth suicide awareness by encouraging schools to implement youth suicide prevention programs; and

WHEREAS, Resolution No. 238 (NEC, August 30-31, September 1, 2016), Subject: "Suicide Prevention for American Veterans Act" urged the U.S. Congress to pass and the President to sign into law an Act to expand and improve care provided to veterans at risk for suicide; and

WHEREAS, There is an urgent need for trained Legionnaires at the post level to intervene in veteran suicide situations in their community; and

WHEREAS, This will enhance awareness and increase the likelihood of recognizing signs of veterans and community members at risk of suicide; and

WHEREAS, Posts can be empowered to prevent as many veteran suicides as possible while working with national and local agencies to return veterans to their community with a sense of belonging and purpose for a safe and productive life; and

WHEREAS, Legionnaires and members of the American Legion Family have the desire and the ability to save lives; they need to be given the appropriate tools so they can make a difference in saving a life; therefore, be it

**RESOLVED, By The American Legion, Department of Nebraska, in regular convention assembled in Columbus, Nebraska, on June 23, 24, 25, 26, 2022, that Department of Nebraska strongly encourages suicide awareness and prevention training at the post level; and, be it finally**

**RESOLVED, That posts are strongly encouraged to seek out qualified trainers and invite them to provide training for their Legionnaires and members of the American Legion Family.**

WHEREAS, There were 16 million World War II American Veterans, but as of September 30, 2021, only 240,329 remain, with 234 dying each day; and

WHEREAS, Projections show that by September 30, 2025, there will be 400 remaining WWII Veterans; by September 30, 2030, there will be 50; and by September 30, 2035, only 4 WWII Veterans will remain nationally..

WHEREAS, Those surviving men and women of the Greatest Generation are now in their 90s or older; and

WHEREAS, As of September 30, 2021, there were 1,729 World War II Veterans living in Nebraska; and

WHEREAS, Each and every day, first-person memories of World War II – its sights, sounds, terrors, and triumphs are disappearing; and

WHEREAS, It is our duty and responsibility as Americans and fellow veterans to honor and preserve the memories of these veterans of the Greatest Generation many of whom are our parents and grandparents; now, therefore, be it

**RESOLVED, By The American Legion, Department of Nebraska, in regular convention assembled in Lincoln, Nebraska, on June 23, 24, 25, 26, 2022, that every Post in Nebraska should attempt to identify all remaining World War II veterans in their communities, reach out to them, and publicly honor them for their service and sacrifice in a manner agreed upon by the local Post; and, be it finally**

**RESOLVED, That each year at the Department Convention Joint Session, beginning in 2023, all remaining World War II Veteran Legion members in the state identified through Legion.org and from input by Posts will be honored by having their name and Post location read (*read when <100 names*) and also listed in the Convention Program.**

WHEREAS, The Medal of Honor award was signed into law by President Abraham Lincoln in 1861 and 1862, and

WHEREAS, 3,511 members of the Armed Forces of the United States have been awarded the Medal of Honor, our nation's highest award for valor for acting with conspicuous gallantry and intrepidity above and beyond the call of duty at the risk of one's life during wars against enemies of the United States, and

WHEREAS, During 2017-2018, the nonprofit Bend Heroes Foundation managed creation of the 451-mile border to border Oregon Medal of Honor Highway across Oregon on US Highway 20 honoring all of Oregon's 29 Medal of Honor recipients of all wars and was the first state in our nation to do such, and

WHEREAS, During the 5-year period 2018-2022, Bend Heroes Foundation managed creation of the Medal of Honor Highway Across America through 12-states located along the 3,565-mile coast to coast U.S. Highway 20, the longest highway in our nation, and

WHEREAS, Numerous American Legion Posts and Departments across our nation have supported or led designations of the 12-state Medal of Honor Highways which complement one of the purposes stated in The American Legion's Preamble: "To preserve the memories and incidents of our associations in all wars", and

WHEREAS, Each of the 12-state Medal of Honor Highways honors the state's Medal of Honor recipients and recipients from any state who travel on it, and

WHEREAS, The 12-state Medal of Honor Highways along U.S. Highway 20 collectively honor about two – thirds of our nation's 3,511 Medal of Honor recipients with the remaining thirty-eight states accounting for about one- third of all awardees, and

WHEREAS, The United States Congress designated the coast-to-coast Lincoln and Eisenhower Highways honoring two former Commanders-in-Chief who either created or presented Medal of Honor awards during war, and

WHEREAS, Not a single highway across the United States has been designated by the United States Congress to honor all of our nation's Medal of Honor recipients since the Medal of Honor award was created 161 years ago; now therefore, be it

**RESOLVED, By The American Legion, Department of Nebraska, in regular convention assembled in Columbus, Nebraska, on June 23, 24, 25, 26, 2022, That The American Legion, Department of Nebraska, supports this resolution and requests The American Legion national organization to support and encourage the United States Congress to designate the coast to coast U.S. Highway 20 as the "National Medal of Honor Highway" and require appropriate highway signage including display of the three versions of the Medal of Honor medal on all signs, and, be it further**

**RESOLVED, A National Medal of Honor Highway will raise public awareness of the Medal of Honor award and the bravery of our nation's war heroes – an objective of the Congressional Medal of Honor Society chartered by Congress, and, be it finally**

**RESOLVED, Designating the Newport, Oregon to Boston, Massachusetts coast-to-coast U.S. Highway 20 as the National Medal of Honor Highway by the United States Congress would honor all of our nation's current and future Medal of Honor recipients and promote education of the traveling public on the "bravest of the brave" American war veterans.**
