LAW ENFORCEMENT OFFICER OF THE YEAR APPLICATION FORM

PURPOSE: The goal of this program is to select a well-rounded Law Enforcement Officer who has exceeded, above and beyond, the duty requirements expected of his/her position and has demonstrated a distinct pattern of community service coupled with professional achievement. A major secondary purpose is to promote the public trust and support of our law enforcement agencies and officers.

To be eligible for consideration, candidate must:

- Be a citizen of the United States, male or female
- Be a living, active, full-time and paid, sworn law enforcement officer entrusted with full authority and powers of arrest.
- Be assigned to, or fully recognized by, Municipal (City), County, District or State Police (e.g. University Police, etc.) or Highway Patrol, Sheriff's office, or as a sworn Federal law enforcement officer (e.g. FBI or Secret Service Agent, Unites States Federal Marshall, National Park Police, Capital Police, etc.)
- Nominees selected for this award should be available to receive this award at The American Legion, Department of Nebraska mid-year convention in January. Department winner will be nominated for the National Law Enforcement Officer of the Year Award and if selected, will be required to be available for the award presentation at the National Convention.
- Military police officers or investigators are not eligible for participation in this award. Nominees are not required to be veterans or members of The American Legion.

Application packets should include: 1) Completed application form; 2) 5"x7" photograph of nominee; 3) A maximum of 18 one-sided pages of service documentation (service narrative, supporting citations, press articles and recommendation by his/her Supervisor).
